RSPCA Australia National Statistics 2001-2002

The RSPCA receives thousands of animals every year in every State and Territory in Australia. Annual statistics on the numbers of animals received, reclaimed or rehomed are compiled on a national basis by RSPCA Australia. The following statistics cover the 2001 to 2002 financial year and give details on the receipt and placement of animals by each State and Territory RSPCA during that period.

- The RSPCA received 132,054 animals in 2001-2002, down on the previous year's figure by over 2,500 animals (2%). Although the total number of animals received by the RSPCA dropped, four of the eight State or Territory RSPCAs actually received more animals. Most notably, RSPCA SA received 14% more animals than the previous financial year.
- The number of dogs received by the RSPCA continued to fall this year, following the trend over the last 5 years. In contrast, the number of cats and other animals received has been relatively stable for the past 3 years.
- The RSPCA investigated 51,216 cruelty complaints, and initiated 339 prosecutions in 2001-2002. This compares with 48,503 complaints and 364 prosecutions in the previous year. The large increase in complaints mostly reflects an increase of 4,500 complaints in NSW, a figure explained by several calls to evacuate abandoned animals during the bushfires experienced in that state during December 2001. Nearly 50% of cruelty complaints received related to dogs.

Figure 1 The fate of cats and dogs received by the RSPCA in 2001-2002

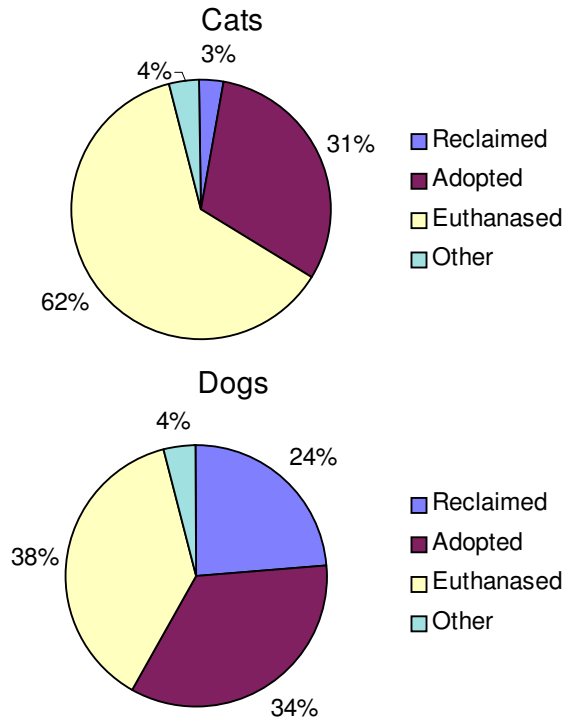
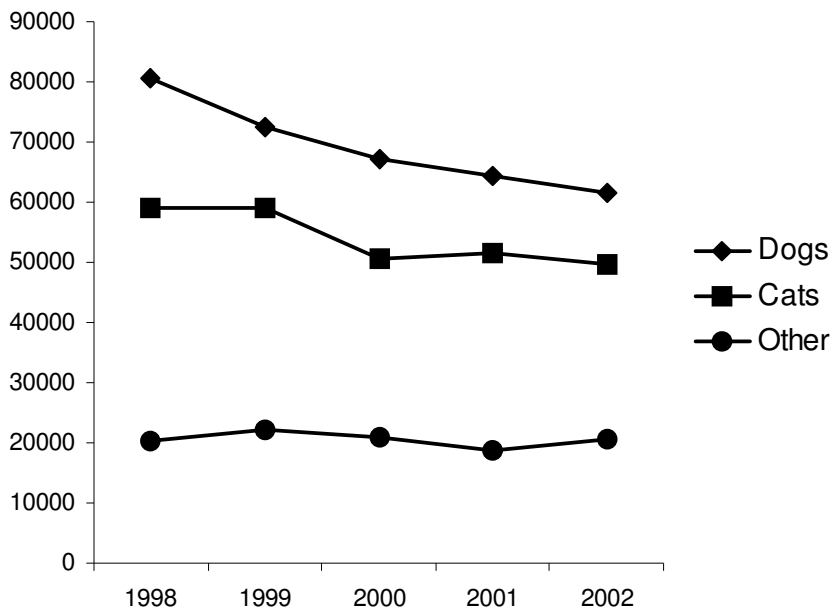


Figure 2 The numbers of animals received over the past five years
